

**Main Street Program, Neighborhood Revitalization,  
The Department of Housing and Community Development**  
\$2.0 Million (S00A24.01)

**Purpose: American Rescue Plan Funding**

The Neighborhood Revitalization program, in the Department of Housing and Community Development shall establish a grant program to help preserve the State's main street economies.

**June 30 - Program Highlights and Plans to Allocate Remaining Balance:**

- All of the state designated Main Street Maryland communities (33) and the Baltimore City designated Main Street neighborhoods (8) have been awarded funding to support local grants to businesses within their Main Street districts. Awards were based on applications submitted to DHCD's Maryland Strong Economic Recovery Initiative: Main Streets by the nonprofit organization or local government responsible for administering the local Main Street program. All the 41 Main Street awardees have received their award payments and have begun to distribute those funds to their businesses.
- In addition to providing grants to their local businesses, the Main Streets were able to use up to 15% of their awarded funds for operating to support the administration of their grant program and/or for use on programs and activities that would directly support the businesses in their Main Street district. The Main Streets have until June 30 to spend the awarded funds. Final reports from the 41 Main Streets will be due no later than July 30 and will include information on the local businesses that they funded.
