\$20.0 Million (S00A24.01)

Purpose: American Rescue Plan Funding

The DHCD shall distribute funds to local governments to provide grants to non-profits that can demonstrate need, with priority given to organizations that have not received assistance through the Neighborhood Revitalization Program.

June 30 - Program Highlights and Plans to Allocate Remaining Balance:

- DHCD shall distribute the funds based on the population of the counties and Baltimore City. The funds will be awarded to the county economic development offices or other county agency as identified by the local jurisdiction and the City of Baltimore will receive the funds directly. Each awardee shall utilize its own local grant program to distribute funds and shall prioritize awards to nonprofits that have not already received relief funds from DHCD's Nonprofit Recovery Initiative (NORI).
- As of June 25, DHCD Finance has processed and submitted to the Comptroller's office for payment a \$19,967,753 of the \$20,000,000 allocated. At the request of Carroll County government \$32,247 of their awarded funds are being provided to Carroll Community Foundation and DHCD is in the process of finalizing an agreement with the foundation to deploy the funds to them. Funds awarded to the local governments will be awarded via their local nonprofit grant programs no later than September 1.
