#### **SUMMARY**

The Board of Public Works ensures that State expenditures are necessary, appropriate, fair, and lawful. To this end, the Board, which consists of the Governor, Comptroller, and Treasurer, approves State contracts. The Board also authorizes capital improvements for State government offices, District Court facilities, and several statewide programs including asbestos abatement, major maintenance projects known as facilities renewal projects, and replacement of all state-owned underground heating oil storage tanks. These programs and facilities are generally managed by the Department of General Services.

Between FY 1996 and FY 2005 statewide programs were funded as follows:

- \$16,542,000 was provided for asbestos abatement
- \$98,252,000 was provided for facilities renewal projects
- \$10,550,000 was provided for underground storage tank removal and replacement
- \$27,800,000 was provided for construction of a statewide High Speed Data Network
- \$34,648,000 was provided for the upgrade of the statewide Public Safety Communications System

In addition to continued funding for statewide programs, the five-year capital improvement program includes funding for improvements to a State office building in Baltimore City, and new District Court facilities in Allegany, Montgomery, and Queen Anne's Counties. These projects will increase public access to government buildings and judicial proceedings.

#### Changes to FY 2006

#### Additions:

Construction Contingency Fund (C): Funds to supplement the Construction Contingency Fund were added in FY 2006 to meet unanticipated construction expenses through FY 2006.

#### Deletions:

**Legislative Facilities (E):** Funds to purchase capital equipment for the addition to the Lowe House Office Building have been deleted due to other budget priorities.

State Office Building #3 - 2100 Guilford Avenue (C,E): Funds to renovate 2100 Guilford Avenue were deferred until FY 2007 due to delays encountered in the design schedule of the building renovations.

**High Speed Data Network (C,E):** Funds to construct and equip the High Speed Data Network were deferred until FY 2007 because existing funding is sufficient to perform proposed FY 2006 work.

#### Changes to FY 2007 - FY 2009

Funds for the acquisition and construction of additional parking at the Centreville District Court/Multiservice Center were added to FY 2007.

#### Major Changes:

During the 2004 Legislative Session, the Governor's Office for Individuals with Disabilities was formally designated the Department of Disabilities. Consequently, projects for Accessibility Modifications, which formerly appeared under the Board of Public Works, will now be shown under the Department of Disabilities.

The building houses offices of the Division of Parole and Probation.

Existing system deficiencies will be corrected by constructing new infrastructure specifically designed to meet current and future communication systems needs of State and participating local government public safety agencies. The non-budgeted funds represent in-kind contributions and donations of property and equipment from Kent, St. Mary's, Somerset, Wicomico, and Prince George's Counties and the U.S. Department of Transportation. The estimated cost of this project totals \$104,000,000.
